The Digital Document Vault™ is a trademarked, patent-pending service of DOTJobHistory.com which allows our members to securely safekeep copies of important documents in our Digital Safe Deposit Box™.

You can review and manage your document copies at DOTJobHistory.com. You may grant access to all or part of your document copies to potential employers as part of our Verified Driver™ membership service.

The Digital Document Vault™ contains two distinct parts:

- Driver Digital Safe Deposit Box™
This is for your documents.
- DOTJobHistory Certified Data
Certain of the information that DOTJobHistory obtains with your express permission directly from the source is also kept in a separate part of the Digital Document Vault™ under your name.

Certified data may include your National Driver Register Report, a DOTJobHistory exclusive never before made available to prospective employers.

All this information is available for your review 24/7 through DOTJobHistory.com.

Why Do You Need a Digital Safe Deposit Box™?

Two reasons—

First, if you are currently seeking a new driving job, the availability to prospective employers of documents like your safety awards and driving school diplomas as part of our verified driver report will give you the first look from those employers.

Second, important documents have a way of getting mislaid, especially those that you need to save for many years, such as military discharge papers. As a member of DOTJobHistory.com you will always have them available when you need them.

Everything you store in your Digital Safe Deposit Box™ is confidential, and can only be copied by you or released to prospective employers with your permission.

For example, you will want to share copies of any safety awards with prospective employers, but you may not want to share the details of employment history reports from former employers back more than the years required to be disclosed under DOT rules.*
